In regard to the above mentioned reference and subject it is informed that looking to the supportive evidences presented by you and the opinion of the site inquiry of the inquiry committee recognition is given to start a non granted new school standard 1 to 5 English medium from the academic year June 2016 in connection to your application and in relation to the provisions of Bombay primary education act 1949, rule 106(kh) on condition to follow schedule (F) and not taking grant.


