1	School has uploaded affidavit dated 18.06.2016 against land certificate which is not as per Appendix-X, however, as per SARAS 4.0 Circular no.16/2023 dated 28.04.2023 land certificate should be issued not more than 01 year before the date of application; therefore, school is required to upload land certificate issued by DM/ ADM/ SDM/ Tehsildar/ Naib Tehsildar/ Registrar/ Sub Registrar/ Equivalent Land Authority STRICTLY as per Appendix-X of Circular no.12/2022 dated 14.10.2022 clearly depicting the details of actual owner of land (by way of Sale Deed etc.), who had further leased the land to School or Society/Trust running the school.
