## Important:

- i) This NOC is issued with condition that all the fire fighting equipment is periodically tested, repaired and maintained.
- ii) A mock fire fighting drill shall be conducted once in six months, under information to the local fire officers.
- iii) Comply fully with NBC norms within six months of receiving this NOC if any shortfalls arise in due course of time or at the inception.
- 5) The Management is responsible for all risks involved in case of Fire Accident.
- 6) This Periodical Occupancy Renewal Certificate is valid for a period of Three (03) years only from the date of issue of this NOC to the management of M/s Sri Swamy Narayan Gurukul International School, R.S. No.64/1, Navepotavaram, Ibrahimpatnam Mandal, NTR District. The Owner/ Occupier/ Builder/ Management concerned of the Building shall submit Affidavit/Self Declaration/Certification with regard to working condition of above Fire Safety system and Electrical Safety Compliance report every year in the prescribed format and submit/upload the photographs of the Mock Drills conducted in the premises.
- 7) It is the responsibility of the Builder to maintain the Fire Safety equipment in good working condition at all times and apply for next Periodical Occupancy Renewal Certificate, duly remitting the User Charges vide G.O.Ms.No.90, Home (Prisons & Fire Services) Department, Dated:13.08.2021 & G.O.Ms.No.120, Home (Prisons & Fire Services) Department, Dated:25.10.2021, two (02) months before expiry of this Renewal of No Objection Certificate.
