1	The total number of section of the school shall be restricted to 36. Further increase of section shall be subject to specific approval of the Board on the basis of the request of the school as per affiliation by elaws and subject to the availability of room size of greater than 500 sq ft.
2	The school name is mentioned as Shree Swaminarayan Gurukul International School instead of Shree Swaminarayan Gurukul School (as in application) in the documents like:- recognition certificate, land certificate, building safety certificate and water and sanitation certificate. Hence the school is directed to correct the school name in school website, obtain revised documents with correct school name and upload the same on SARAS portal within 3 months.
3	The fire safety certificate obtained in the name of society. The school is directed to obtain renewed certificate in the name of school.

4	The library is understocked. The school shall upgrade the library as per SoP issued by the Board and submit the compliance within 3 months on SARAS portal.
5	no work stations with utilities are seen in composite lab. Wooden side slabs(inappropriate) are seen with equipment and sinks. However they hinder movement and experimentation and hence should be used only for storage. plastic chairs which are a fire hazard are seen in the lab which should be removed immediately. The school shall upgrade the lab as per SoP issued by the Board within 3months and submit compliance on SARAS with videography.
6	The school has overlaid a ramp over a staircase to access the upper floors, which is not acceptable as it is steep and unsafe. The school shall dismantle it and construct a proper ramp as per norms of RPwD Act and guidelines issued by the Board or install a lift within 3months and submit compliance on SARAS with videography.
7	The school has converted regular cubicles into CWSN toilets which are too small and narrow for a wheelchair/walker to enter and navigate and hence are not as per norms. CWSN toilets are not seen on every floor. The school shall construct CWSn toilets for boys on every floor with proper permanent signage as per norms of RPwD Act and guidelines issued by the Board within 3months and submit compliance on SARAS with videography.
8	As seen in the RC video, the school does not seem to have referred to SOPs issued by the board for labs and library or to RPwD Act and guidelines issued by the Board in respect of CWSN infrastructure and has made half baked attempts at provisioning for the same. The school is strongly advised to follow the SOPs of the Board and guidelines in respect of CWSN infrastructure which is a statutory requirement.
9	The school shall conduct training of its teachers with CoE Vijaywada within 3 months and submit the compliance

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII, as the case may be.

The approval of the Board as mentioned above, is subject to the following conditions:-

- 1. The school shall be responsible for its genuineness of the documents/ data/ information uploaded by the school. In case of any discrepancies, action will be initiated against the school as per Affiliation Bye Laws-2018.
- 2. The school shall follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt. from time to time. The school will also abide by the conditions prescribed, if any, by the State Government concerned.
- 3. The School shall apply online for extension of affiliation along with the requisite fee and other documents as per Rule 10.3 of Affiliation Bye Laws.
- 4. The school shall go through the provision of Affiliation and Examination Bye Laws and subsequent amendment therein as well as circulars and guidelines /instructions issued by the Board time to time and keep a copy thereof for reference purpose and is also advised to regularly visit CBSE websites i.e., http://cbseacademic.nic.in/ & http://cbse.nic.in/ for updates.
- 5. The school shall renew mandatory certificates from time to time.
- 6. The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity /activity related to running of school affiliated to CBSE. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.
