ORDER:

The Management has submitted the proposals through the Mandal Educational Officer, Yerpedu (M) for Grant of Recognition for classes I to VII (E.M.) from the academic year 2025 - 2026 vide in the reference 8th read above.

The Undersigned has verified the Proposals for Grant of Recognition for classes I to VII (E.M) in respect of Shree Swaminarayan Gurukul School, Vikruthamala village, Yerpedu Mandal, Tirupati District with reference to the visit report/remarks & recommendations of the Mandal Educational Officer, Yerpedu Mandal and also with the references mentioned above and to the conditions laid down in the G.O.Ms.No.1, Edn., dated: 1-1-1994.

After careful examination of the Proposals to the references cited and conditions prescribed in G.O.Ms.No.1, Edn., dated: 1-1-1994 permission is hereby accorded for Grant of Recognition for classes I to VII (E.M.) from the academic year 2025 - 2026 to 2032 – 2033 (without aid) in respect of **Shree Swaminarayan Gurukul School, Vikruthamala village, Yerpedu Mandal, Tirupati District** with the following conditions.

However, by the end of April every year, the Educational Agency shall file an affidavit to the effect that there is no deviation or violation of norms/rules prescribed by the Government from time to time and the management is requested to comply with the following without fail.

1	That the Society/Trust shall abide by the Instructions/rules regulations made by the Government or authorized officer from time to time.
2	That the educational Institution shall serve the needs of the locality more particularly.
3	That the Institution shall adopt the curriculum and syllabus prescribed from time to time.
4	That the school timings, vacations and mid-terms holidays shall be as prescribed by the Government from time to time.
5	That the qualified staff within the age limits prescribed by the Government for Government employees shall be appointed as per the staff pattern.
6	That the results of institution shall be satisfactory every year.
7	That the records/accounts shall be furnished to the district Educational officer or nominee every year at the time of instruction.
8	That the list of governing body shall be furnished to the District Educational Officer/competent authority every year.

9	That the pay structure/fee structure fixed by the Governing body shall got approved by the District Educational Officer or nominee every year.
10	That all the conditions prescribed in the G.Os. And other orders which are not specified in this order shall be complied with. Otherwise, the recognition will be cancelled.
11	that the school shall not be closed without giving notice both to the parents / District Educational Officer and competent authority at least 6 months before.
12	That the school shall be closed or permitted to be closed only from the date on which summer vacation is declared.
13	That the society shall submit proposals for Renewal of Recognition sufficiently in advance as per G.O.Ms.No.1, Edn., dated:1-1-94.
14	The above Recognition is subject to a written undertaking being given by the school Management that the recognition purely on temporary basis and is subject to the reports of State Level Inspection and Vigilance Committee fulfilling of all the pre-requisite conditions under the A.P. Education Act, 1982 and if later found that the school has not fulfill any prerequisite as stipulated, the Recognition now being is liable to be withdrawn at once.
15	The Management is requested to fulfill all the conditions stipulated in G.O's read above.
16	The Management should follow the fire safety measures issued by the government strictly and should obtain the Fire No Objection Certificate for occupancy in prior and periodically without fail.
17	The management should follow the provisions of RTE Act.
18	The management shall submit an affidavit with regard to non-violence of rules/regulations prescribed by the Government from time to time.


The Inspection Officer, Deputy Educational officer has caused inspection and submitted his/her report in the reference 2nd cited.
